
Dear Manitou Association Members,

GBA Updates

Our Treasurer, Jenifer Martin, had the pleasure of attending the GBA's 2023 AGM. The Georgian Bay Association was founded in 1916 and is an umbrella organization for 19 cottage associations on the shores of Georgian Bay plus one inland lake. They represent over 34,000 people and advocate on our behalf with all levels of government and non-government entities to protect our interests – they are our voice on The Bay. 2023 Dues

There will be a slight increase of \$10 for primary memberships & voting privileges: \$120 per property owner (\$60 to Manitou and \$60 (up from \$50) to GBA). Secondary memberships for additional families, couples or individuals who share a property have increased from \$50 to \$55 (\$25 to Manitou and \$30 (up from \$25) to GBA). The secondary membership provides the same benefits without voting privileges. Along with supporting the crucial work done by the GBA an our behalf, membership benefits include a listing in the Manitou directory, login access to www.manitouassociation.com, email updates and direct mailings from Manitou Association, Georgian Bay Association and Georgian Bay Forever. • Near North Crime Stoppers

- It is a non-profit designed to enhance community safety across the districts of Nipissing and Parry Sound. Since inception in 1988 NNCS has received nearly 22,000 tips, contributing to the arrest of over 1700 individuals. They have recovered \$4.2M in property and seized over \$52M in drugs destined for our communities.

New Tax: Underused Housing Tax Form for Non-Canadian Property Owners

- The federal government put forth this new 1% annual tax levied on the value of residential property that is vacant or considered underused. The intention of this tax is to make housing more affordable for Canadian residents by deterring non-residents from passively investing in Canadian real estate.

- Non-Canadian residents must submit a UHT Tax Form (deadline was April 30, 2023 but given this is the first year, no penalties or interest will be applied for UHT returns and payments that the Canada Revenue Agency receives before November 1, 2023. See more details in the link below:
